Section. 30(c) – Prejudice to Effective Conduct of Public Affairs

An exemption under section 30(c) of FOISA (prejudice to effective conduct of public affairs) applies to some of the information requested. Disclosing this information would substantially prejudice our ability to prevent and detect error by jeopardising ongoing error prevention work or risk compromising ongoing error detection activity. This would constitute substantial prejudice to the effective conduct of public affairs in terms of the exemption.

We have assessed this request against the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open, transparent and accountable government. However there is a greater public interest in protecting the processes for preventing and detecting error and ensuring that the Scottish Government is able to conduct this effectively. This means that we have not disclosed the value & volumes of errors and types of errors involved.
