

Carer Support Payment

What is Carer Support Payment?

In Scotland, Carer Support Payment has replaced Carer's Allowance from the Department for Work and Pensions (DWP). Carer Support Payment is money for people who look after someone who is disabled or who has a long-term health condition.

Who can apply?

To be eligible, a carer must

- be 16 or over
- provide 35 hours or more of unpaid care a week to someone of any age who is getting certain
- · disability benefits
- earn £196 per week or less on average after some deductions

How much is Carer Support Payment and when will it be paid?

Carer Support Payment is £83.30 per week or £333.20 every 4 weeks.

Can I get Carer Support Payment if I'm working?

Carers who have paid work alongside their caring role can be eligible if their 'take home pay' from work is less than £196 per week.

'Take home pay' is pay after income tax, National Insurance, and some expenses, including some care costs and pension contributions are taken off. If a carer's 'take home pay' is sometimes more than £196 and sometimes less, Social Security Scotland can work out how much their average take home pay is.

Can someone get Carer Support Payment if they receive other benefits?

People can get Carer Support Payment at the same time as other benefits. If they get 'meanstested' benefits such as Universal Credit, Carer Support Payment may affect the amount they get. They'll usually be better off overall because they can get extra amounts in these benefits for being a carer.

If a carer gets 'income replacement' benefits such as State Pension or 'new-style' Employment and Support Allowance, this may affect the amount of Carer Support Payment they can get.

If their benefit is worth the same as or more than Carer Support Payment, they may have 'underlying entitlement'. This means they will not receive any money in Carer Support Payment, but might be able to get additional benefits or top ups to existing benefits, including Pension Credit.

Does getting Carer Support Payment impact the benefits of the cared for person?

The disability benefits of the person being cared for (including Child Disability Payment. Adult Disability Payment, Pension Age Disability Payment, Scottish Adult Disability Living Allowance, Attendance Allowance and Disability Living Allowance) should not be affected because their carer gets Carer Support Payment.

If the person being cared for gets a Severe Disability Premium – an extra amount included in some means-tested benefits – this may stop if the carer gets Carer Support Payment. This is because a Severe Disability Premium helps to cover the cost of care. The rules for Severe Disability Premium can be complex, and changes to Severe Disability Premium may impact other benefits, so we recommend seeking further advice.

Can students get Carer Support Payment?

Carer Support Payment is available to more carers in education than Carer's Allowance, the benefit it replaces. Carers aged 16 or over can get Carer Support Payment if they are studying part-time. People aged 20 or over who are studying full-time are also eligible. Carers aged 16 to 19 studying full-time may be eligible, depending on the type of course they are studying and their circumstances.

Carers will not normally be able to get Carer Support Payment if they are studying Nationals or Highers at secondary school or college. They may be eligible if they are able to get other benefits, such as Universal Credit, while in full-time education.

Additional financial support

Carers getting Carer Support Payment on a certain date will also get Carer's Allowance Supplement. This is paid automatically.

How should people apply?
