



# Carer Support Payment





**Carer Support Payment** is replacing Carer's Allowance from the DWP in Scotland.



Carer Support Payment is money from **Social Security Scotland**. It is paid to people who look after someone who is:

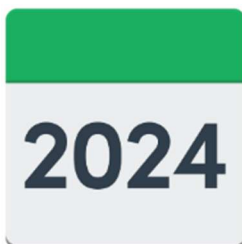
- disabled, or
- has a long-term health condition



The payment is starting in phases. From 20 November 2023, people in 3 local authority areas have been able apply.

These 3 areas are:

- Perth and Kinross
- Dundee City
- Western Isles



People in more areas can apply from Spring 2024. The payment will be available across all of Scotland in Autumn 2024.



To be eligible for Carer Support Payment, a carer must:

- be 16 or over
- do 35 hours or more of unpaid care a week to someone who is getting certain disability benefits
- earn £139 a week or less (on average, after some deductions)
- live in an area where you can get Carer Support Payment



Carer Support Payment is the same amount as Carer's Allowance. This is currently £81.90 a week or £327.60 every 4 weeks. People can get Carer Support Payment at the same time as other benefits.



Getting Carer Support Payment could affect the amount someone gets in means-tested benefits like Universal Credit. They will usually still be better off overall though. This is because they could get extra money in means-tested benefits for being a carer.



The amount of Carer Support Payment someone gets could also be affected if a carer gets income replacement benefits like:

- State Pension, or
- 'New-style' Employment and Support Allowance



If someone's benefit is worth the same as or more than Carer Support Payment, they may have 'underlying entitlement'.



‘Underlying entitlement’ means someone will not get any Carer Support Payment, but might be able to get:

- other benefits, or
- top ups to benefits they already get, like Pension Credit



A carer getting Carer Support Payment should not affect the disability benefits of the person they care for. These disability benefits include:

- Adult Disability Payment
- Child Disability Payment
- Personal Independence Payment
- Disability Living Allowance



Severe Disability Premium is an extra amount included in some means-tested benefits.



If someone a carer looks after gets a Severe Disability Premium, they will usually stop getting this when their carer gets Carer Support Payment. They may also stop getting reduced Council Tax



Someone living in Scotland and already getting Carer's Allowance does not need to apply for Carer Support Payment. They will automatically be moved to Carer Support Payment. They will get a letter to let them know when it is happening.



All students over 20 years old who care for someone can apply for Carer Support Payment. Students that are 16-19 years old will not be eligible if they are studying certain courses full-time. These courses include Nationals or Highers at secondary school or college.



Carer's Allowance is only available to students studying part-time. This means more students will be able to get Carer Support Payment, which replaces Carer's Allowance.



If a student gets Carer's Allowance and wants to study full-time, they may be able to apply for Carer Support Payment instead. They can do this when it becomes available in the part of Scotland they live in.



Carers getting Carer Support Payment, or Carer's Allowance from the DWP, on a certain date, will also get Carer's Allowance Supplement.



Carer's Allowance Supplement is an automatic payment of £270.50. It is paid twice a year.
