#### 1. Welcome and Conflicts of Interest

- 1.1. The Chair welcomed and thanked everyone for their attendance and noted the apologies as listed above.
- 1.2. No potential conflicts of interest were noted.
- 1.3. The Executive Advisory Body endorsed the minutes from the last meeting on 26 November 2024.
- 1.4. Members welcomed Karyn Dunning, newly appointed Deputy Director, Low Income Benefits and Operational Improvement, to her first Executive Advisory Body meeting.

## 2. Chief Executive and Chief Operating Officer's Update

- 2.1. The Chief Executive and Chief Operating Officer provided updates on the following:
  - Leadership of the People and Place Division as Deputy Director, Nicola Rudnicki, is on maternity leave.
  - The Scottish Government's recruitment for the replacement of Permanent Secretary JP Marks is progressing following his announcement to move to HMRC.
  - Reflections on Social Security Scotland's evidence session to the Parliament's Social Justice and Social Security Committee. Discussions included the 2023-24 Annual Report and Accounts, preparations for the Social Security Programme Closure and a range of operational issues.
  - The introduction of Gayle Devlin and Karyn Dunning as Deputy Directors in Client Services Delivery along with a breakdown of their responsibilities and areas.

## 3. Social Security Scotland Performance Update

- 3.1. Members were presented with the latest performance update with the following key points highlighted:
  - Ongoing activity to reduce absence.
  - Child Disability Payment processing times have increased but remain within tolerance. Improvements are expected as new Case Managers complete training.
  - 445,000 Winter Fuel Payments have been processed.
  - Funeral Support Payment demand and resource.

- Data sharing work is ongoing with a front-door process established.
- 3.2. Members discussed the Social Security Programme closure, which is still on track for 2026.

## 4. Budget Update

- 4.1. SD provided members with an update to the Social Security Scotland budget 2025-26 and advised the following:
  - Work is underway on the 2025-26 Budget Paper which will outline divisional budget allocations which is due in March 2025.
  - An update on the Future Operating Model. There is close collaboration with Social Security Programme to manage the collective budget.
  - As agreed with the Scottish Government, the 2025-26 Budget for Benefit Expenditure is in line with the latest Scottish Fiscal Commission estimates which were published in December 2024.
- 4.2. Members discussed the impact of changes to National Insurance rules for employers and the financial approach to be undertaken by Social Security Scotland.
- 4.3. Members discussed the main costs associated with recruitment.

# 5. People Survey and People Plan

- 5.1. MG presented highlights from the People Survey results and members were advised of the following:
  - Scores are broadly in line with other large Civil Service delivery bodies.
  - Results have been shared with governance groups, trade unions and colleagues.
  - The Executive Team have agreed Divisions will take forward actions and integrate them into business plans.
- 5.2. BG presented the People Plan and advised members of the following:
  - Insights from the 2023 People Survey are being used to develop the People Plan.
  - Collaboration with trade unions is ongoing, with plans to roll out results to colleagues through drop in sessions.
  - Links between the People Survey and People Plan will be established.
- 5.3. The Executive Advisory Body discussed themes identified across each Division and the ongoing work required to analyse responses to understand reasons and decisions needed by the Executive Team.

### 6. Adult Disability Payment

- 6.1. Edel Harris, the author of the Independent Adult Disability Payment review, was welcomed by members to discuss interim report findings and next steps. The following was highlighted:
  - The final report will be presented to Scottish Ministers in July 2025.
  - A breakdown of recommendations contained within the report.
  - The interim report outlines initial findings, early actions that can be taken, and themes for exploration in the second stage.
  - The second stage of the review is underway with stakeholder meetings focusing on eligibility criteria.
- 6.2. Members were advised of feedback by stakeholders with many expressing feelings of being treated with kindness and are supportive of Scotland's Social Security system.
