4. Feedback from Attendees on Report

4.1 Feedback on action plan was positive. Members raised a number of points including:

- Further time to discuss the report with colleagues before formally endorsing could be beneficial.
- Resources appear to be mainly based online, which is not accessible to many people in Scotland.
- Concerns were raised about some of the language in the report. In some places
 perhaps too high level. Suggestion that there could be a version focusing on
 implementing the plan and a higher level version for those who want to see
 further background information.
- Face to face support on inclusive communication for colleagues should be considered alongside a helpline service.
- A navigation note could prove useful when using the action plan.
- Continuing to work with people with lived experience in the design and production of resources is fundamental to success
- 4.2 HF advised that Social Security Scotland works closely with partners across the Scottish Government and the summary action plan will be shared further.
- 4.3 As members wanted more time to speak with colleagues and consider endorsing the action plan, a date was set for an email response.
